There is a **30** athlete maximum, entries are determined on a first come first serve basis.

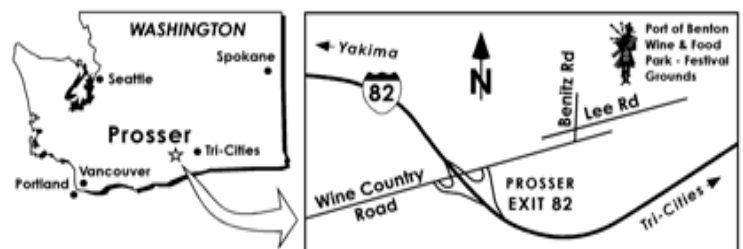
