1. Dance competition will follow the rules of the SOBHD
2. Dance entries will not be accepted without a FUSTA /Scotdance registration number
3. Dancers must have their FUSTA /Scotdance card to pick up awards
4. Entries must be postmarked by June 6, 2014. Double entry fees apply after June 6, 2014.
4. Field entries may be accepted at the discretion of the Dance Committee, double entry fees apply
5. Class breakdown will be determined by the dance committee when all entries have been received
6. Decision of the judge is final. Any protest must be made in writing and handed to the Dance Committee.
7. Dancers must dance to the piper provided
8. Any dancer not ready when called, shall forfeit entry in that event
9. Good sportsmanship is required of all competitors, parents and spectators.
10. Highland and National dance points will be combined to calculate the aggregate trophy winner.
11. No refunds given for dancing entries received. Entry fees are payable in US funds only. Entry fees from Canada must be by money order.
