1. Dance competition will follow the rules of the RSOBHD
2. Dance entries will not be accepted without a RSOBHD registration number
3. ALL dancers must have their RSOBHD card in order to compete on the day of the event
4. Entries must be postmarked by June 1, 2022
5. Registration Table will open at 8:30am
6. Collect your competitor numbers at the Registration Table
7. Field entries may be accepted at the discretion of the Dance Committee & double fees apply
8. Class breakdown will be determined by the dance committee when all entries have been received
9. Decision of the judge is final. Any protest must be made in writing and handed to the Dance Committee with \$25 fee, nonrefundable.
10. Dancers must dance to the piper provided
11. Any dancer not ready when called, shall forfeit entry in that event
12. Good sportsmanship is required of all competitors, parents and spectators.
13. Highland and National dance points will be combined to calculate the aggregate trophy winner.
14. No refunds given for dancing entries received. Entry fees are payable in US funds only. Entry fees from Canada must be by money order.
15. Premiers 16 years and over will be awarded CASH prizes
16. **Choreography- Premier Dancers only**
 - **Time limit not to exceed: Solos 2 minutes or Duets/Groups 4 minutes**
 - **Must supply own music CD/Bluetooth**
 - **Must be Celtic theme and use Highland/National movements**
 - **CASH Awards for placings**
