**Prosser Dance Rules and Entry Information**

1. Competition will begin at **10 AM**.
2. Dance competitions will run under the rules of SDUSA & RSOBHD.
3. No refunds given.
4. Schedule of events will be available online.
5. Any dancer causing a delay will forfeit his/her entry in event. It is dancer's responsibility to follow platform schedule.
6. First to enter, last to dance.
7. \$2 from each entry goes towards SDUSA NW Region.
8. All groups will receive medals except adult premier class who will receive cash awards. An aggregate trophy will be awarded in each class except Primary.
9. Age groups will be split according to entries.
10. Age is determined as of day of competition.
11. All judges' decisions are final. A \$40 protest fee must accompany any formal written protests.
12. Choreography -Open to both Pre-Premier & Premier Dancers. 3 min max. **Cash prizes to be awarded.**
  - \* **Must send music in MP3 format to Gail Bacon prior to competition.**
  - \* Must have Celtic theme and use Highland/National movements.
